### IOWA DELTA MAKES STRIDES TO RETURN TO DRAKE CAMPUS

#### Join Us at Founders' Day and Relays

s you read this, I hope you are making arrangements to attend Relays this year. Although we are without a chapter house, many brothers make it back for Relays, and in the near future, Phi Delts will live at 1245 34th Street again.

In November 2009, Drake University decided to cease recognition of our charter for four academic years (until the fall of 2014), and concurrently Phi Delta Theta International Headquarters suspended our charter, both as a result of the conduct of a number of undergraduate Phis and Phikiea. The Housing Corporation, along with the help of some local alumni, made one key decision in the early days of our suspension: Iowa Delta would return to Drake University. This determination has guided all of our decisions since that point, with most likely the most important decision being to renovate the house and lease it to a sorority.

Time has flown. We have a multi-year lease in place with a sorority. We have maintained contact with a growing number of Iowa Delta alumni and have continued to foster a positive relationship with Drake University and Phi Delta Theta International. The result? We have a dramatically better chapter facility than the one we had. We have a core of local alumni poised and ready to bring Iowa Delta back to Drake, Drake University is ready for our return, and we are on Phi Delta Theta International's recolonization calendar for 2014.

We are positioned well for 2014, but we will need your help. This year, you will be hearing about our progress, and you will be asked to join in. Plan to be at Relays in 2014, as we will be using that weekend to make our return to Drake.
